## **Arnprior Legion Hall Rental Information and costing**

### **Hall Rental Options**

#### **Board Room**

- Cost: \$25 per hour or \$100 for the entire day
- Availability: 1:00 PM to 7:00 PM
- Capacity: 12 people
- Deposit: \$100 required

#### **Daytime Rental**

Events: daytime rental for meetings, events without a bar, children's birthday party (4 Hours)

- Legion Members: \$150
- Non-Legion Members: \$200
- Set up and tear down: \$25 per hour with a 2-hour minimum
- Availability: 1:00 PM to 5:00 PM

Deposit:

- Meeting: \$50 non-refundable deposit + \$100 security deposit
- Party: \$50 non-refundable deposit + \$200 security deposit

#### **Stags/Engagement Parties, Weddings, Birthday Parties, or Special Occasions**

Cost

- Legion Members: \$500
- Non-Legion Members: \$600
- Setup, night before: \$75 (2 hours Max.)
- Availability: 9:00 AM to 1:00 AM
- Deposit: \$50 non-refundable + \$200 security deposit

Cost:

- Members/Veterans: By Donation
- Non-Members: \$100
- Availability: 9:00 AM to 1:00 AM
- Deposit: \$50 non-refundable deposit

### Hall Capacity (including any entertainers and bar staff):

- Alcohol: 223 people
- No Alcohol: 258 people

### Liability:

Liability insurance is included but does not cover the use of the kitchen.

### Deposit Explanation:

#### 1. Security Deposit

- Will be returned if the hall is left clean and undamaged after the event.
- All customer decorations and belongings must be removed.
- Garbage must be bagged and placed in designated spaces.
- Kitchen use is not permitted.
- The person signing for the event is responsible for any damages incurred.
- If damage costs exceed the damage deposit, the person who signed for the event is liable for the additional cost.
- Cash, debit or bank draft only.

#### 2. Non-Refundable Deposit

- This deposit is required to hold the booking.
- If the event is canceled, the deposit will not be returned.



### **Booking Confirmation**

The booking is not confirmed, and the date is not held until the deposit is received.

### **Booking Payment**

The booking must be paid in full at least 2 weeks before the event date.

### **Person Signing for the Rental**

The person signing for the rental must be present throughout the entire event, remain sober, and is responsible for any damages that occur during the event.

### **Use of Kitchen**

Kitchen use is not permitted for customers. If customers bring in their own sandwich buffet, all food must be prepared off-site. The bar staff will store prepared food in the beverage cooler and set it out at the required time. Kitchen liability coverage is not provided.

### **HST**

All rates include HST.

### **Coffee & Tea**

Coffee and tea are available upon request for Stags/Engagement Parties, Weddings, Birthday Parties, or Special Occasions.
